Treasurer's Report

Mr. Schuster, Treasurer, reported on the balances in the Money Market and the Checking Accounts as of 3/15/18. There was a fee of \$500 collected in January of 2018 and interest earned to date is \$181.78. The net income is -1,323.96.

Auditor's Report.

Luke Malecki CPA, Partner of Drescher and Malecki and his Associate, Nicole Ruf, CPA were present to give the Independent Audit Report for 2017. Luke Malecki passed out copies of the Audited Financial Statements and a power point presentation. The reporting included the products of the Audit which are the Basic Financial Statements, the Management Letter and the Auditor Communications.
